Dereliction - David Broom, Former Consul General, Seattle and Commonwealth and Foreign Office

Everyone has the right to freedom of opinion and expression. This right includes freedom to hold opinions without interference and to seek, receive, and impart information and ideas through any medium regardless of frontiers. Probably the most important violations of human rights in this case relate to the denial of freedom of speech and assembly also arbitrary incarceration based upon coerced declarations.

Council House resorted to unlawful incarceration with solitary confinement and eviction also search and seizure of property to support denial of due process. Moreover, the court arbitrarily and unconstitutionally prohibited entry to large areas of Seattle for almost five years.

The court denied full equality at a fair and public hearing before independent and impartial judges. It evaded its responsibility to account for its actions and denied cross-examination of allegations then frustrated and manipulated appellate court procedures in a cover up.

Everyone charged with a punishable offense has the right to a presumption of innocence until proven guilty in a public trial at which they have all the guarantees necessary for their defense - especially in a case that involves criminal charges and imprisonment. No court can legally find a person guilty of a crime on account of any act or omission under international law.

David Broom, former Consul General, Seattle and Judge James A. Doerty, conspired to deny most of those rights and have since covered up their unlawful actions in consort with UK Commonwealth and Foreign Office.

I append the documents that you requested which includes a copy of my recorded mail letter (05 Apr 04/14:28) to The Right Honorable Jack Straw MP, formerly Secretary of State for Foreign and Commonwealth Affairs, Foreign and Commonwealth Office to which he did not respond, hence my request for your intervention. That letter will apprise you of the situation.

I allege that David Broom was not only derelict in his responsibility to visit me in jail but also actively conspired with a Seattle judge through *ex parte* contact to deprive me of my human and constitutional rights. This resulted in unlawful incarceration for 111 days (including 25 days in solitary confinement) under the most appalling conditions.

You will learn from the correspondence that Broom also neglected to respond to requests for action by Rosalie A. Gillman and others and chose to ignore the barrage of negative publicity about the court action.

Perhaps even more seriously, Broom has consistently mounted a cover-up of his actions by withholding public records which now facilitates harassment by US officials each time that I enter the US. Moreover, Seattle police and Council House directors use his neglect to constantly harass me by filing false and misleading criminal charges against me in attempts to return me to jail.

The recent (30 Mar 06) finding by Washington Supreme Court bears out my contention that both Judge James A. Doerty and David Broom respectively used judicial or diplomatic immunity in a conspiracy to deny me my human and constitutional rights.

I request a copy of any files that carry my name and full investigation and explanation of the Kafkaesque liaison between former David Broom, HM Consul, Seattle, Washington, USA and Washington Superior Court Judge James A. Doerty before I request civil and human rights lawyers and advocates in consort with International Federation of Journalists to file complaints in accordance with the Universal Declaration of Human Rights.
